

## Probate Notes for February 19, 2016

Probate notes are a recommendation as to the outcome of the petition. Unlike tentative rulings, they do not automatically become adopted as the order of the court. Unless an appearance at the hearing is otherwise required by law, if petitioner submits a proposed order prior to the hearing and the recommendation is to grant the petition, no appearance is necessary. If you are scheduled to appear and there is no probate note issued in your case, you should appear as scheduled. If you wish to continue a matter, you must contact the civil division at (530) 406-6704, at least two (2) court days before your hearing.

**CASE:            Conservatorship of Jurado**  
**Case No. CV P2 14-107**

The parties are **DIRECTED TO APPEAR** for the continued hearing as ordered by the Court on January 8, 2016.

**CASE:            Conservatorship of Okuloff**  
**Case No. CV PB 81-16472**

It is recommended to approve the court investigator's report and twenty-first verified account and report of conservator. (Prob. Code, §§ 1850 et seq., 2620, 1060.)

**CASE:            Conservatorship of Truitt**  
**Case No. CV PB 78-15196**

It is recommended to approve the court investigator's report and seventeenth verified account and report of conservator. (Prob. Code, §§ 1850 et seq., 2620, 1060.)

**CASE:            Conservatorship of Webber**  
**Case No. CV PC 12-205**

It is recommended to approve the court investigator's report and second verified account and report of conservator. (Prob. Code, §§ 1850 et seq., 2620, 1060.)

**CASE:            LPS Conservatorship of Finch**  
**Case No. LP SQ 14-51**

The Court notes the following deficiencies:

1. The petition is missing one of the required affidavits from a licensed physician and/or psychologist stating that the conservatee is still gravely disabled. (Welf. & Inst. Code, § 5361.)
2. The affidavit of Richard Brouette, M.D. is dated December 24, 2016, which has not yet occurred.

It is recommended to approve the verified seventeenth account and report of conservator and to grant the petition for reappointment of conservator. (Welf. & Inst. Code, § 5350 et seq.)

**CASE: LPS Conservatorship of Patton  
Case No. CV PB 97-56**

It is recommended to approve the verified nineteenth account and report of conservator and to grant the petition for reappointment of conservator. (Welf. & Inst. Code, § 5350 et seq.)

**CASE: LPS Conservatorship of Prescott  
Case No. CV PB 74-13555**

It is recommended to approve the verified thirty-third account and report of conservator and to grant the petition for reappointment of conservator. (Welf. & Inst. Code, § 5350 et seq.)
