HOW DOES ONLINE DISPUTE RESOLUTION ("ODR") WORK?

- Go to yolocasc.modria.com to register and create your case.
- Plaintiff will start the process by making an offer to Defendant of the amount they are willing to accept to settle the case prior to trial.
- An email will be sent to
 Defendant showing the offer
 made by Plaintiff. Defendant
 may agree to that offer or
 provide a counter-offer.
- If the parties are not able to reach an agreement on their own, either party can request the help of a trained mediator.
- If after 45 days you have not settled your case, the online negotiation will end and your case will go forward to trial.

ONLINE MEDIATORS

- Mediators are trained professionals who can help the parties understand the issues and find a resolution that works for both parties.
- If both parties agree to mediate, a mediator will be assigned to the case and will contact the parties to initiate the mediation. All of this is done online.

RESOLVE YOUR CASE QUICKLY WITHOUT COMING TO COURT

WHAT HAPPENS IF WE REACH AN AGREEMENT

- If an agreement is reached, a written agreement will be prepared automatically and will be emailed to both parties for signature.
- Once signed, the agreement will be emailed to both parties and it will automatically be filed with the court.
- Once the agreement is filed with the court, it becomes enforceable by the court, and the case will be dismissed.
- The case may be re-opened by either party if that party feels that the other party is not following the terms of the agreement as written.
