Courthouse Tour Code of Conduct

- 1. Dress Code, visitors will not be allowed entry if they are wearing any of the following:
 - > Shorts
 - ➢ Flip flops
 - > Tank tops
 - Sunglasses
 - > Hats, or
 - > Any other attire inconsistent with the traditional dignity of the court.
- 2. To ensure that visitors to the courthouse have a safe experience. All persons and items entering the Courthouse must enter through the designated public entrance and are subject to full weapons security screening, which includes walking through a magnetometer and all hand-carried items being passed through an x-ray scanner.

Access to the Courthouse shall be denied to any individual who possess any of the following items:

- 4. It is expected that you will show respect to all court staff, security officers, and private individuals you meet while you are in the courthouse.
