This is the Bail Schedule of Yolo Superior Court adopted pursuant to Penal Code section 1269b (c) and (d). The purpose is to set the amount of bail for the release from custody prior to the first appearance of a person arrested without a warrant.

At the defendant's first appearance and at each hearing thereafter, pursuant to Penal Code section 1269b (b), the amount of bail, if any is allowed, shall rest within the sound discretion of the judicial officer presiding and may be set greater or lower than schedule bail, subject to the provisions of Penal Code section 1275, related statutes, and the Supreme Court's decision in *Humphrey*.

At the time of arrest without a warrant and pursuant to Penal Code section 1269c, the arresting officer may submit a declaration under penalty of perjury to the On-Call Magistrate requesting an order setting a higher bail based on the circumstances. Except where limited under law, the defendant may make a similar request to lower bail.

The bail amount set on any warrant pursuant to Penal Code section 815a or other provisions of law supersedes this Bail Schedule.

Under this schedule, bail for felony offenses shall be set based on the highest maximum state prison term applicable to the single charged offense, including any applicable count and case enhancements.

When a person is charged with multiple offenses, bail shall be set based on the single charge having the highest maximum sentence, including any applicable count and case enhancements. Stacking of charges is not authorized under the Bail Schedule, but may be ordered by the Court pursuant to Penal Code section 1269c

The On-Call Magistrate is also available to issue an Emergency Protective Order (EPO) requested by law enforcement pursuant to Family Code sec. 6215, 6240 and related statutes. An EPO may be issued for an arrest involving domestic violence, child abuse, elder abuse, and stalking. An EPO is in effect for a maximum of 7 calendar days. At the arraignment hearing, the Court may issue a Criminal Protective Order for an additional period of time.

The On-Call Magistrate is also available to consider requests under Penal Code section 1275.1 to hold the release of a defendant pending a determination of whether any portion of the money or consideration made for execution of bail was feloniously obtained.

The arraignment for any arrestee who has posted bail shall be set based on the same time provisions applied to an arrestee who remains in custody pursuant to Penal Code section 825. The arrestee shall appear in Court before a judicial officer within 48 hours after his or her arrest, excluding Sundays and holidays. However, when the arrest occurs on a Wednesday after the conclusion of the day's court session, and if the Wednesday is not a court holiday, the arrestee shall appear in Court no later than the following Friday, if the Friday is not a court holiday.

Under appropriate circumstances, the Court may consider setting the custody status of the defendant at NO BAIL. The grounds for No Bail are set forth in the California Constitution under art 1, sec. 12 and art. 1 sec. 28 (f)(3). A No Bail custody order requires the judicial officer to make a record based on an individualized assessment that the facts are evident or the presumption is great that the defendant has committed a qualified offense and by clear and convincing evidence that a danger exists and no lesser condition or combination of conditions of restraint will reasonably assure the safety of the public or the victim or the appearance of the defendant in Court.

For all felony offenses identified in Penal Code sec. 1270.1, Bail shall be calculated by adding \$10,000 to the scheduled amount. These offenses include all enumerated serious and violent felonies and violations of Penal Code sec. 136.1 (c) (dissuading witness), section 262 (spousal rape), section 273.5 (domestic violence), section 422 (criminal threat), section 646.9 (stalking), section 273.6 (violation of court order with prior). Except as otherwise allowed by section 1269c, before any person who is arrested for any of these offenses may be released on his or her recognizance or on bail in an amount that is either more or less than the Bail Schedule, a hearing shall be held in open court before a judicial officer.

Also pursuant to Penal Code section 646.93 (c), the following conditions of bail shall apply for all felony offenses identified in Penal Code sec. 1270.1: no contact with the victim by any means; stay 100 yards away from the victim, the residence, and place of employment; do not possess any deadly weapons or firearms; obey all laws; and provide the Court with residence contact information.
