Stationary Local 39, AFL-CIO**

10.11 Bilingual Pay.

The Employer's bilingual pay program shall provide for two levels of interpretation skills, duties and competence. Qualifications and certification to such positions shall be determined by the Employer. Positions for which bilingual skills are necessary shall be determined by the Employer.

10.11 a) Conversational: The level of providing oral and written interpretation between English and another recognized language. The compensation for this level shall be thirty one cents (\$.55) per hour for all hours worked (regular or overtime).

10.11 b) Advanced: The advance level of providing written interpretation to interpret technical documents and concepts with a client in addition to the skills and abilities required at the Conversational level. The compensation for this level shall be thirty eight cents (\$.75) per hour for all hours worked (regular or overtime).
