Probate Notes for July 18, 2025

If you are scheduled to appear and there is no probate note issued in your case, you should appear as scheduled. Case: In the matter of Nomuun Chadraabal (Limited Conservatorship)
Case No. PR-2024-0121

It is recommended to approve the court investigator's report for continuation of the conservatorship. (Prob. Code, § 1850 et seq.)

It is recommended to waive reimbursement of \$450 to the Court for the court investigator's report.

It is recommended to set a biennial review for July 16, 2027.

Petitioner is directed to submit a proposed Order prior to the hearing. No appearance is necessary.

Case: In the matter of Jaime Ortega (Conservatorship)
Case No. PR-2025-0142

The Court notes the following deficiency: The *Confidential Declaration on Medical Ability to Attend Hearing - Probate Conservatorship Form* (GC-325) has not been filed with the Court or the proposed conservatee has not otherwise been excused from being produced at the hearing. It is recommended for the Court to issue the lodged Letters. Petitioner is directed to submit a proposed Order prior to the hearing. No appearance is necessary.

Case: Conservatorship of Wolfley Case No. PR-2009-163

Parties are **DIRECTED TO APPEAR** and be prepared to advise the Court as to the status of filing the Confidential Conservatorship Care Plan (Judicial Council forms GC-355 and GC-356) as required by Probate Code section 2351.2. (Eff. Jan. 1, 2025.)

Case: In the matter of Wayne Abraham (Conservatorship)
Case No. PR-2022-0002

The Court notes the following deficiency: The Confidential Conservatorship Care Plan (Judicial Council forms GC-355 and GC-356) is incomplete. Specifically, in Part 1, paragraphs 1, 2(a) and (b), 3(a), (b) and (d) - (g), 4(a) and (b), 6(a) and (b) and 11(a) or (b) have not completed and paragraph 9(a) has not been fully completed.

Parties are DIRECTED TO APPEAR.

Case: Conservatorship of Cha (Limited)

It is recommended to approve the court investigator's report for continuation of the limited conservatorship. (Prob. Code, § 1850.5 et seq.)

It is recommended to approve the court investigator's report for continuation of the limited conservatorship. (Prob. Code, § 1850.5 et seq.) It is also recommended to approve the conservator's care plan. (Prob. Code, § 2351.2.)

It is recommended to waive reimbursement of \$450 to the Court for the court investigator's report.

It is recommended to set a biennial review for July 16, 2027.

Petitioner is directed to submit a proposed Order prior to the hearing. No appearance is necessary.

Case: Conservatorship of Ornelas (Limited)
Case No. PR-2007-102

It is recommended to approve the court investigator's report for continuation of the limited conservatorship. (Prob. Code, § 1850.5 et seq.)

It is recommended to waive reimbursement of \$450 to the Court for the court investigator's report.

It is recommended to set a biennial review for July 16, 2027.

Parties are **DIRECTED TO APPEAR** and be prepared to discuss conversion of this limited conservatorship to a general conservatorship.

Case: Conservatorship of Rentfrow Case No. PR-2012-89

The Court notes the following deficiency: A comprehensive report of the conservatorship investigating officer has not been filed with the Court. (Prob. Code, § 1851.)

Parties are **DIRECTED TO APPEAR**.

Case: Conservatorship of Singh Case No. PR-2018-50

The Court notes the following deficiencies:

- 1. The Confidential Conservatorship Care Plan (Judicial Council forms GC-355 and GC-356) is incomplete. Specifically, in Part 1, paragraphs 6(a) and (b), 9(a) or (b) and 11(a) or (b) have not completed.
- 2. The Confidential Conservatorship Care Plan (Judicial Council forms GC-355 and GC-356) was not served on the conservatee's siblings, as required. (Prob. Code, § 2351.2, subd. (a)(2).)
- 3. Parties are **DIRECTED TO APPEAR**.
- 4. Petitioners are **DIRECTED** to submit proposed Letters of conservatorship prior to the hearing based on the Court's June 15, 2021, order converting this conservatorship from a limited conservatorship to a general conservatorship.

Case: Conservatorship of Yeargain Case No. PR-2013-218

Parties are **DIRECTED TO APPEAR** and be prepared to advise the Court as to the status of filing the Confidential Conservatorship Care Plan (Judicial Council forms GC-355 and GC-356) as required by Probate Code section 2351.2. (Eff. Jan. 1, 2025.)
